#### 8. Board Matters:

a. Consider Accepting the Final Audit Report for Fiscal Year 2021-2022 as Presented by Fechter and Company. Mrs. Villa introduced Joanne from Fechter and Company. Joanne gave an overview of the audit process. There were no findings but the District did have a net change. The District remains in good standing. There were a few questions from the Board.

b. Consider Authorizing the General Manager to Enter into a Contract with Pacific Site Management Landscaping for Landscape Maintenance Service in the amount of \$6,818 Monthly. Mr. Long stated that the contract with Pacific Site Management has expired. The District received three responses to the RFP. The lowest responsible bidder was Pacific Site Management. They have been with the District since 2016 and the District has been pleased with their work. There were a few comments from the Board.

c. Consider Selecting a Redesigned Playground Structure for 5-12Year Old to be Installed at Anuta Park. Mr. Long corrected the item from "selecting" to "approving" the redesigned playground structure as there is only one option. He reminded the Board that the District started with a \$269,000 budget but when it came time to bid on the original structure, the price increased to \$450,000. Dave Bang Associates provided a new design that still meets the needs of park users. The new design will require another \$75,000, which can come from Park Impact Fees received this year. The Board likes the redesigned playground structure and the fact that it is an open design.
