- 3. Hickory Meadows Park County approached District to fund a \$10k capital improvement project at Hickory Meadows; may be a great opportunity to replace bark with Pour-in-Place rubber surfacing
- 4. BPYA Graduation graduation was outstanding; Rande and Alondra, along with their volunteers, did a great job; program is very popular
- 5. Recreation/Programs about 80 guests attended movie night and 26 attended night swim; next Hot August Movie Night will be August 18th; aquatic center will be open weekends only through Labor Day weekend; soccer program completely full; dance program will be finalized in the next couple of weeks
