5. General Manager's Report:

The General Manager and Recreation Coordinator provided brief reports on the following topics:

- 1. Clearland Property anticipated to close in early 2023.
- 2. BPYA in process of recruiting new members; awarded \$40,000 from Koshland/San Francisco Foundation
- 3. Pool had a great partnership with East Bay Regional Parks; had over 4,500 admissions, sold 195 season passes, 372 participants for swim lessons; looking to add additional programing for the 2022-2023 season
- 4. Lynbrook Project installation will begin end of October/beginning of November; anticipating grand opening at the end of November
- 5. Anuta Project community meeting is scheduled for September 24th; anticipating March grand opening
- 6. Bocce Building demo is complete; need to repair retaining wall
- 7. Upcoming Programs and Events Soccer Camp begins September 20th; Volleyball Camp will begin November 1st; sponsoring Ambrose Garden Harvest Day event on September 17th, along with the Contra Costa County Health Services and other businesses and organizations
- 8. Holiday Events Halloween event has a tentative date of October 28th; Breakfast with Santa will be in person this year; also planning for Easter Eggstravaganza

8. Board Matters:

a. Consider Authorizing the General Manager to Execute a Contract in the Amount of \$44,750 with Pacific Site Management to Install an Irrigation System at Ambrose Park. Mr. Long reminded the Board that installing a new irrigation system was necessary after the installation of the storm drain. The District advertised a Request for Proposal and received one from our current landscape maintenance company. The project will cost the District less than anticipated. The General Manager is also requesting to reassign the unused funds from the Lynbrook project to offset the cost.
